JASDEC (JAPAN) AND KSEI (INDONESIA) SIGN MOU ON INFORMATION SHARING AND COOPERATION

Tokyo and Jakarta - Japan Securities Depository Center, Inc. (JASDEC) and PT Kustodian Sentral Efek Indonesia (KSEI) signed a Memorandum of Understanding (MOU) on November 12th, 2009.
