

Appendix (Fee Table for the Pre-Settlement Matching System)

Amended on January 1, 2024  
Notice as of December 1, 2023

1. Based on Article 17, Paragraph 3 of Rules Concerning Matching of Settlement Condition, etc. for Securities Transactions, etc. (hereinafter referred to as "Rules"), fee rates prescribed by JASDEC in Article 17, Paragraph 2 shall be stipulated as Fee Rates A and B below. Users shall pay JASDEC the total amount of fees (the sum of Base Fee, Trade Matching Fee, Settlement Matching Fee and Integrated Web Terminal Usage Fee) calculated by the choice of fee rate from either Fee Rates A or B, plus the corresponding Consumption Tax and Local Consumption Tax.

2. Change in the choice of fee rates shall be conducted on a monthly basis. Users shall apply to JASDEC by the 25th of the preceding month (the preceding business day if the 25th is not a business day of JASDEC) in order to change the choice of fee rates. Unless the User applies to JASDEC for the change of fee rates by the due date, the fee rate for the following month shall not be changed and Users shall pay the sum of fees calculated by the current fee rate plus the corresponding consumption tax and local consumption tax.

3. If the User consents all or in part matching of settlement conditions, etc. of securities transactions, etc. to the Settlement Agent or Operation Agent, fees shall be the amount calculated by the fee rate chosen by the entrusting User.

4. Notwithstanding the provisions of Article 17, Paragraph 2 of the Rules and Paragraph 1 of this table, in cases where (i) the User entrusts all or in part matching settlement conditions, etc. of securities transactions, etc. to the Settlement Agent and (ii) the relevant User and relevant Settlement Agent apply in accordance with the procedures prescribed by JASDEC to the effect that the Settlement Agent will incur the payment obligation of Base Fee, the relevant Settlement Agent alone shall incur the obligation to pay Base Fee. In this case, Base Fee to be paid by the relevant Settlement Agent based on this paragraph shall be the same as Base Fee calculated for the relevant User by Paragraph 1 and the preceding paragraph if there is one Settlement Agent with payment obligation, and Base Fee to be paid by respective Settlement Agent based on this paragraph shall be half of each Base Fee (omit less than 1 yen) calculated for the relevant User by Paragraph 1 and the preceding paragraph if there are two or more Settlement Agents with payment obligation. Furthermore the payment obligation of Base Fee incurred for respective Settlement Agent shall be mutually separate and independent obligations if there are two or more Settlement Agents with payment obligation of Base Fee.

5. Notwithstanding the provisions of Article 17, Paragraph 2 of the Rules and Paragraph 1 of this table, in cases where (i) the User entrusts all or in part matching settlement conditions, etc. of securities transactions, etc. to the Settlement Agent and (ii) the relevant User and relevant Settlement Agent apply in accordance with the procedures prescribed by JASDEC to the effect that the Settlement Agent will incur the payment obligation of Integrated Web Terminal Usage Fee (limited to the corresponding number of Operational User IDs that the relevant Settlement Agent has registered for the relevant User), the relevant Settlement Agent alone shall incur the obligation to pay Integrated Web Terminal Usage Fee (limited to the corresponding number of Operational User IDs that the relevant Settlement Agent has registered for the relevant User). In this case, the Integrated Web Terminal Usage Fee to be paid by the relevant Settlement Agent based on this paragraph shall be the Integrated Web Terminal Usage Fee calculated for the number of Operational User IDs registered for the relevant User (The number of Operational User IDs that the relevant Settlement Agent has registered for the relevant User shall be handled separately without aggregating the number of Operational User IDs that the relevant User has registered by itself and the number of Operational User IDs that the relevant Settlement Agent has registered for itself.) by the provisions of Paragraph 1 and 3.

6. Applications to JASDEC prescribed in the preceding two paragraphs shall be submitted by the 25th of the preceding month (the preceding business day if 25th is not a business day of JASDEC) to change the obligor for payment of Base Fee or Integrated Web Terminal Usage Fee based on the relevant application. If the application is made by the relevant due date, the Settlement Agent related to the relevant application shall pay Base Fee or Integrated Web Terminal Usage Fee from the month designated by the relevant application.

7. If the party that filed an application prescribed in Paragraphs 4 or 5 applies to the effect that the User is the obligor of Base Fee and Integrated Web Terminal Usage Fee (hereinafter referred to as "change reapplication") in accordance with procedures prescribed by JASDEC, applications prescribed in Paragraphs 4 and 5 become invalid for the future and the relevant User shall incur the obligation to pay Base Fee or Integrated Web Terminal Usage Fee pursuant to the provisions of Article 17, Paragraph 2 of the Rules and Paragraphs 1 and 3 of this table in accordance with the content of change reapplication. Provisions prescribed in the preceding paragraph apply mutatis mutandis to due dates and effective dates of change reapplication.

8. If Users start or suspend or terminate usage in the middle of the month, Base Fee and Integrated Web Terminal Usage Fee shall be the amount (omit less than 1 yen) calculated by the fee rate of choice multiplied by the number of days of usage divided by the number of business days of JASDEC for the relevant month. Trade Matching Fee and Settlement Matching Fee shall be the amount calculated by the choice of fee rates.

9. Notwithstanding the provisions of Paragraph 1 and preceding paragraph, if the monthly total amount exceeds 100 thousand yen, Investment Managers shall pay JASDEC the cap of 100 thousand yen plus the corresponding consumption tax and local tax for the sum of Base Fee, Trade Matching Fee and Integrated Web Terminal Usage Fee calculated by the choice of fee rates and the preceding paragraph.

10. Fees prescribed in this table for the current month shall be paid by the last business day of the following month.

11. JASDEC, when a User (refers to the relevant Settlement Agent for the relevant obligation if the Settlement Agent incurs the obligation to pay Base Fee or Integrated Web Terminal Usage Fee based upon applications prescribed in Paragraphs 4 and 5) fails to pay the relevant fee by the payment deadline provided for in the preceding paragraph, may collect from the said User an arrearage penalty at the rate of 0.04 yen per day for each 100 yen of unpaid amounts.
